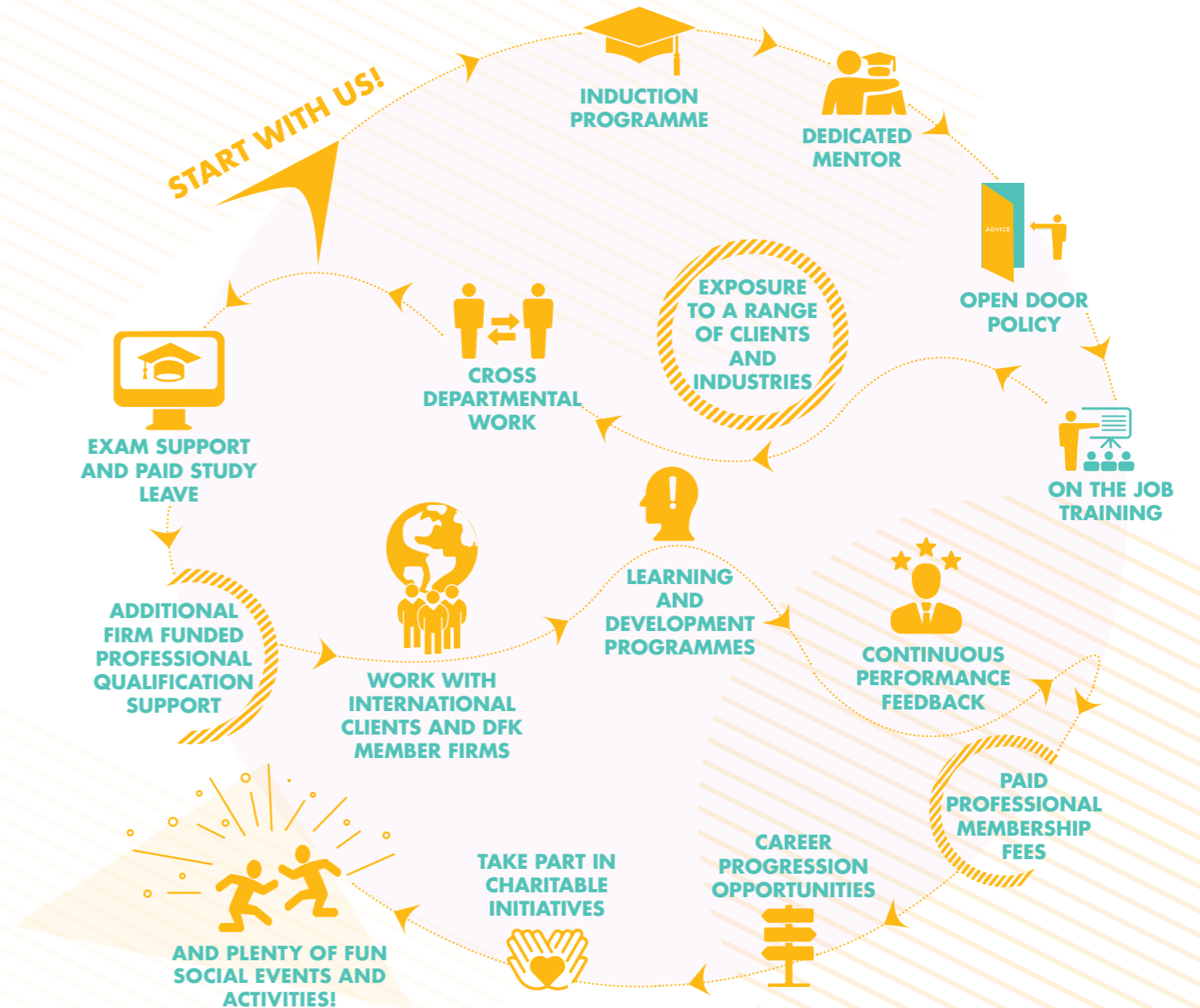

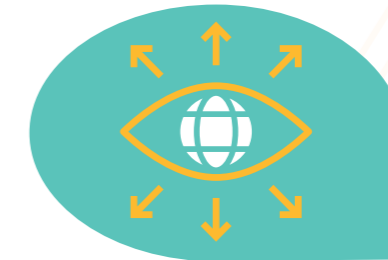

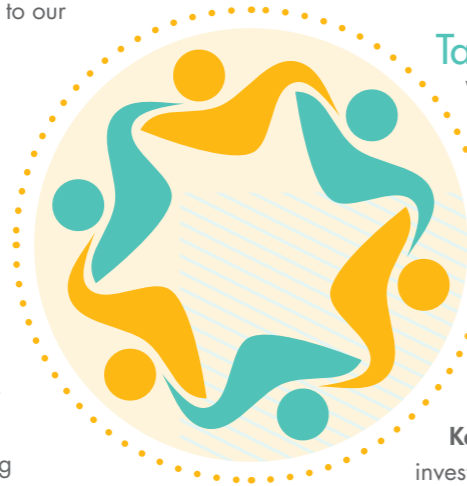
### Working Towards a Sustainable Future
